As part of this, we ask that you review the included explanations and sign the explanation page indicating that you have reviewed that important information.

You also agree that you will keep Boeing Distribution Services informed of changes (for example, a new end-use) and update this certification so that Boeing Distribution Services can meet these regulatory requirements.

As you review this certification and its attached explanations, please contact us with any questions. Going forward, if you have changes or questions, please let us know. Boeing Distribution Services is relying on its close teamwork with you, our customer, to make sure that all sales are consistent with these important export controls.

Absent changes that may require a change to the certificate before that time, Boeing Distribution Services will ask you to renew this statement on a periodic basis.

(1) Nuclear activities:

This means design, development, production or use of weapon delivery systems, such as rockets and missiles, including (but not limited to) ballistic missile systems, space launch vehicles, sounding rockets, unmanned air vehicles including cruise missile systems, target drones, and reconnaissance drones.

(4) Military activities

This means research, design, support, development, use, construction or any other activity regarding weapons, articles of war, defense articles, munitions, or technologies specifically modified or designed for military application of any sort. Military end users can include national armed services (army, navy, marine, air force, coast guard), as well as national guard and national police, government intelligence or reconnaissance organizations, paramilitary organizations, or any person or entity whose actions or functions are intended to support military end-uses or activities.
